Parental Undertaking – College Rules

I / We the parent(s)/ guardian(s) understand the implications of the following **conditions of enrolment** and agree to abide by the pledges therein to the best of my/our capacity:

- The applicant (student) shall attend all lessons and activities. Failure to do so will necessitate the student to provide a signed explanatory note from either parent or guardian and if required, a medical certificate may be requested.

- The student will not be allowed to leave College grounds unless under staff supervision.

- I/We agree to the student attending excursions outside of school grounds during school hours and under the supervision of staff for promotional and educational purposes.
- The College reserves the right to terminate the contract on the grounds of poor attendance or poor behaviour. We understand that continual poor attendance/behaviour may result in cancellation of the student's visa.
